

# Bisley Base Ltd

## Admissions and Fees Policy

Bisley Base Ltd is registered with Ofsted; our registration number is EY429384. We provide care for 50 children between the ages of 4 and 11, primarily serving the children of Bisley and Holy Trinity Schools.

**Pre School** will be registered for 20 2 ½ - 5 year olds

Places are offered on a first-come first-served basis. When all places have been filled a waiting list will be established, with the following order of priority:

1. Siblings of children already attending
2. Those requiring the greatest number of sessions/hours per week
3. Children living in the area attending other schools
4. Sibling of children who live in the area attending other schools

Holiday places are offered on a first come first serve basis, places for 3-year olds will only be offered if they are potty trained and out of nappies.

### Registration

When an enquiry regarding places is made, parents or carers will be given all the relevant Club information, including:

- Information regarding availability of places
- Details of the **Admissions and Fees** policy
- Registration form, medical form, parent contract, booking form, photo permission form
- **Behaviour Management** policy
- **Complaints** policy
- **Club Handbook**

If a place is available, the parents and child will be invited to visit the club for an induction. The child will be able to attend the Club as soon as the completed forms are received.

If no places are available the parent will be inform and the child's name added to the waiting list. As soon as suitable places become available parents will be informed.

### Booking procedure

Parents must complete the necessary paperwork, ie contract, registration, medical, booking and photo permission forms, before their children can attend the club.

- **Permanent place:**

Once booked, if a child does not attend for any reason, you will still be charged for this place. If you wish to cancel the place altogether, half a terms notice in writing is required.

- **Temporary booking:**

We will accept temporary or occasional bookings as long as there are places available. If a temporary place has been booked and is no longer required, the club must be given 48 hours notice. If notice is not given, the place will still be charged for.

### Fee structure

Fees are charged at £6.75 for Breakfast and £16.00 for after school per day.

## Pre School Fee structure

(£1.75 per day will be charged to cover snacks and consumables if on funded space)		
Self Funded Mon-Thurs	9.15-2.15	£25.00
Late pick up	2.15-3.30	£6.50
Extended late pick up	2.15-6.00	£18.00

Pre School will charged £100 once a place has been offered to accept this space, this is refundable at the end of their time with us or it can be used to cover £1.75 daily charge or for any wrap around care.

The Club recognises that childcare can be costly, so we encourage eligible parents or carers to claim the childcare element of the Working Tax Credit. We are also registered to accept childcare vouchers.

- Fees are payable half termly in advance as per Surrey County Council dates.
- Fees can be paid by electronic transfer, cash or childcare voucher
- There is a charge of £10 per 15 minutes for late collection, which will be added to the next invoice
- The club accepts childcare vouchers
- Fees are charged for booked sessions whether the child attends or not if a session falls on a bank holiday or inset day charge will be made. (Although we may not open)
- Late payment fee of £10 will be charged for non-payment by due date.

## Payment of fees

Fees are reviewed annually by the registered person. The Club will consider requests for variation to payment terms on an individual basis. Anyone making these requests should contact the manager at the earliest opportunity. Any queries regarding fees should be directed to the manager.

If fees are not paid, the Club will write to the parent or carer, requesting payment. If the parents or carers are having difficulty making the payment on time we recommend that they arrange a meeting with the manager as soon as possible.

Where there is no explanation for repeated late payment, the manager will contact the parents or carers to discuss payment options. The manager may issue a formal warning to the parent or carer informing them that continued late payment will result in their child's place at the Club being withdrawn.

If the fees remain unpaid after all the above options have been explored, the Club may have to cancel the child's place.
